

Wireless Glass Break Detector

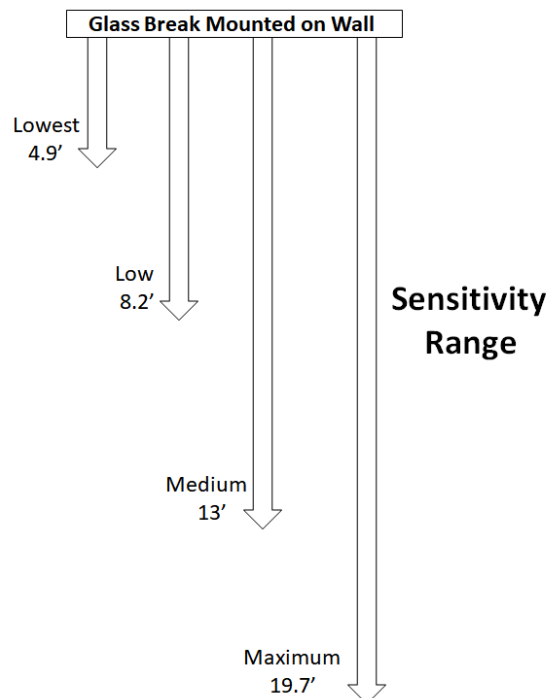

The Wireless Glass Break Detector is used to detect breaking glass that may result in entry - sending an alarm to the control panel.

The Glass Break Detector sends signals for;

- Alarm
- Tamper
- Low Battery

Red LED light is used to convey messages on detector status. Powered is supplied by two long-life replaceable 3-VDC, Lithium batteries.
